What is NexGen?

NexGen is a six-session leadership development program comprised of a series of educational events designed to enhance the leadership skills and knowledge of young, high-potential construction professionals.

Whom Should Be Nominated?

Have you ever thought, "One day that kid could be my boss..."?

NexGen is for those young professionals for whom you see a "future" with your firm. Ideal candidates will have at least two years commercial construction industry with some supervisory or project management experience.

Those with no supervisory or project management experience may be considered based on employer recommendation.

How is Training Structured?

Bi-weekly NexGen sessions will be held September through November. Most sessions will begin at noon and include lunch, presentations by industry leaders, workshops and small group work.

Sessions will explore practical leadership themes that NexGen members can immediately put to work.

NexGen participants will be encouraged to work closely with a mentor and with their employers to enhance professional development throughout the program.

Application Details

Individuals must be nominated by their employer.

The participant fee is \$795.
